# Step In Time Training LLC and the Berkshire Sniffers

**Trial Location:** 

4H Fairgrounds, Utility Drive, Pittsfield, MA

Doors open: 8am; Judges briefing: 8:30am; First dog on the line: 9am Trial will take place indoors and outdoors.

\*\*NOTE: This is prime tourist season in the Berkshires so make your B+B or motel reservations early

Target Odor Tests:

Birch, Anise and Clove

Trial Classes Offered:

Buildings, Exteriors, Speed, Distance, and Containers – a bonus Novice Distance class and a bonus Advanced Exterior is also offered!

> Levels Offered: Novice and Advanced Divisions Offered:

Standard, Metallic, and FEO

TOT and Class Entry Fees: \$10 per TOT; \$20 per run

**NOTE**: Competitors can enter no more than 6 classes and 3 TOTs with one dog. At this trial, a handler can run multiple dogs in TOTs and can run up to two dogs in all Novice classes; handlers may only run one dog in the Advanced classes. In the Novice class, a third dog may run FEO; in the Advanced class, a second or third dog may run FEO. We will award teams Q'ing in 6 classes with the "Iron Nose" Award.

Entry open date: August 9, 2017

Entry close date: October 9, 2017 or when classes fill. Entries are <u>limited</u> and accepted on a first received basis until classes fill. We will have **Day of Show** entries if we do not fill: please contact the Trial Secretary the week of the trial.

Run order will be announced with FINAL entry confirmation email.

## Come and have FUN with your dog!

**Who can compete in a trial?** Any and all dogs that are 10 months or older, on the day of the trial or the Target Odor Test (TOT), are eligible to compete. All Dogs must have their current Rabies Vaccination and other vaccinations recommended by your veterinarian.

**Do I Need to Register with PSD?** PSD registers dogs not people. A \$30 registration fee is good for the lifetime of the dog and can be done instantly on-line.

What if I don't pass the TOT? You can still play!! Dogs must pass a Target Odor Test (TOT) in order to compete in the Standard Division, however if you do not pass you are still allowed to enter the trial as FEO (For Exhibition Only) for the day.

**My dog has a Nose Work title from a different organization, do I have to pass a TOT?** If you already have passed an odor test in another scent work organization, you do not have to take the TOT. Dogs with a NW3, SDDA Excellent or UKC Level 5 title may skip the Novice level and start PSD at the Advanced level. Please send a copy of your test results to info@performancescentdogs.com in order to register.

**Can I watch other competitors?** Yes you can watch, either after you run or you can watch a different level compete.

Can my friend videotape my searches? Yes! And you may post them anywhere you like.

**Awards**: Rosette placement ribbons will be awarded for 1<sup>st</sup>-3<sup>rd</sup> place. Rosettes will be awarded for all New Titles. Ribbons will be awarded for Q's in all classes, including TOT's. A special "Iron Nose" award will be awarded for teams q'ing in all 6 classes entered. The "Iron Nose" is fun and meaningful, but it is also important that we respect the individual capabilities and stamina of our dogs. Note: Dogs do not have to compete in all six classes to participate in the trial. **Fees:** TOTs and Classes: TOTs @\$10; Class Entries @\$20

**Collars** Any collar is allowed on the grounds except scent spraying collars, choke collars and ecollars. Only a flat or martingale collar, harness, or leashes attached to a dead ring, are permitted to be used during a search. <u>No tags</u> on collars while searching. All dogs must be leashed at all times, except during an off-leash search. **Flexi leashes allowed during searches only.** \*\*\*Please pay attention to spatial needs of other dog teams. You must remain vigilant so all teams may have a pleasant experience.

Crating Dogs will work out of their cars; bring shade and lots of water

**Parking** Huge parking area. Please watch for cone or signs indicating an area is off limits for parking: it may be a search area. There will be designated parking for <u>Dogs In Need Of Space</u> (DINOS).

Spectators are invited to come and watch.

**Volunteers** will help our Trial run smoothly. **Donations** Step in Time Training LLC and the Berkshire Sniffers is supporting *Animals For Adoption* in Ulster County NY. The Animals for Adoption shelter provides an innovative, low stress environment for sheltered animals. Dogs are kept in their own rooms complete with furniture, toys, and bedding. They listen to music and are handled and played with every day. **Dogs In Need of Space** The site has plenty of parking and places to walk dogs at a distance of 10 feet or more. There is a single entrance and exit for interior searches that could be congested. Volunteers will be on site to help escort participants to and from the search area. Red bandanas are not required, however please give **all** dogs space.

**Handler running multiple dogs** A handler can run multiple dogs in TOTs at any trial/match. At this trial, a handler may run up to two dogs in the Novice Classes. Handlers may run only one dog in the Advanced classes.

#### Notice to Exhibitors:

- Exhibitors are responsible for complete, accurate and legible information on their entry forms.
- It is expressly understood that exhibitors alone are responsible for behavior of their dogs, children and/or guests. Any exhibitor whose dogs, children and/or guests repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any entry will be made.
- Please be courteous and pick up after your dog. If you don't pick up after your dog, you will be asked to leave the trial site. In such case, no refund on any entry will be made.
- All dogs must be on leash at all times except when allowable at the search site.
- Exhibitors are responsible for being in the staging area when it is their turn to run.
- All entries must be accompanied by entry fees to be valid. A declined payment or returned check does not constitute a valid entry. There will be a \$50.00 fee for any returned check or payment.
