# Performance Scent Dogs Trial July 29, 2018 at Gail Fisher's All Dogs Gym & Inn 505 Sheffield Road, Manchester, NH

**Novice:** Exterior, Building, Speed, Speed, Distance, Containers **Advanced:** Building, Exterior, Speed, Speed, Distance, Containers **Excellent:** Building, Exterior Speed, Speed, Distance, Containers

Novice, Advanced and Excellent

#### **Divisions Offered:**

FEO, Standard, or Metallic

Performance Scent Dogs is a national scent work non-profit organization dedicated to growing the sport of scent detection.

**Try Before You Buy!** Enter the trial without paying for dog registration. If you like your experience and would like to continue to compete in PSD., register your dog within 7 days after the trial to keep your results.

\*Pick and choose what classes are right for your dog \* Videotaping allowed \* Earn legs towards titles \* Competitor feedback encouraged \* Watch and root for other competitors \* Spend time with your dog in a welcoming atmosphere " Turn any search at anytime into training by asking the judge the location of the hide \* Spread the word about what an amazing activity scent work is for all dogs!

**Who can compete?** Any and all dogs that are 10 months or older, on the day of the trial or the Target Odor Test (TOT) are eligible to compete.

What if I don't pass the TOT? You can still play!! Dogs must pass a Target Odor Test (TOT) in order to compete in the Standard Division. However, if you do not pass, you are still allowed to enter the trial as FEO (For Exhibition Only) for the day.

My dog has a Nose Work title from a different organization, do I have to pass a TOT? If you already have passed an odor test in another scent work organization, you do not have to take the TOT. Dogs with a NW3, SDDA Excellent or UKC Level 5 title may skip the Novice level and start PSD at the Advanced level. Please send a copy of your test results to PSD in order to register.

Does my dog have to be in the car all day? No, a crating area will be available to crate your pup or your dog can hang out with you. You can always use your car—where ever your dogs are happiest is where we want them to be.

**Can I watch other competitors?** Yes, you can watch either after you run or you can watch a different level compete.

Can my friend videotape my searches? Yes! And you may post them anywhere you like.

**Awards:** Rosette placement ribbons will be awarded for 1st - 3rd place. Ribbons will be awarded for Q's in all classes. Rosettes will be awarded for new title ribbons.

Fees: Each TOT costs \$15 and each class costs \$18

## Information About Gail Fisher's All Dogs Gym & Inn

**Accessibility** – There is handicapped accessibility into the building. Most searches will be inside; however, if an exterior search is offered, the exterior search will be outside on pavement or rough ground.

Bathrooms - Located inside with hot and cold water.

**Collars** -Electric collars and flexi leads are not allowed on the property of Gail Fisher's All Dogs Gym & Inn. Only a flat, or martingale collar or leash attached to a dead ring or harness are permitted to be used for searches. You may use a long line. For safety purposes, collars should not have tags on them.

**Crating** - A limited crating area will be provided in the arena near the classes.

**DINOS (Dogs In Need of Space)** are welcome to participate. The site has plenty of parking and places to walk dogs at a distance of 20 feet or more. Entry inside the building may be tight and owners are expected to be with their leashed dogs at all times. We ask handlers of DINOS that they help all participants respectfully recognize their dogs by placing a red bandana on their dog for the day.

**Full-Service Facility** - All Dogs Gym & Inn is a full-service facility. Please note that grooming and boarding customers will be coming in and out of the building throughout the day with their leashed dogs. However, some dogs are not as friendly as others.

**Food** - No onsite food is available, but a Dunkin' Donuts and several restaurants are within a five minute drive.

**Hotels** - If you are planning an overnight stay, Best Western Executive Court is very close (\$25/dog - limited availability). (603) 627-2525

**Parking** – There is plenty of parking available. However, please watch for orange cones indicating an area is off-limits for parking. Handicapped parking is available near the front door.
