### **Come and have FUN with your dog!**

**Who can compete in a trial?** Any and all dogs that are 10 months or older, on the day of the trial or the Target Odor Test (TOT), are eligible to compete. All Dogs must have their current Rabies Vaccination and other vaccinations recommended by your veterinarian.

**Do I Need to Register with PSD?** PSD registers dogs not people. A \$30 registration fee is good for the lifetime of the dog and can be done instantly on-line.

**What if I don't pass the TOT?** You can still play!! Dogs must pass a Target Odor Test (TOT) in order to compete in the Standard Division, however if you do not pass you are still allowed to enter the trial as FEO (For Exhibition Only) for the day.

**My dog has a Nose Work title from a different organization, do I have to pass a TOT?** If you already have passed an odor test in another scent work organization, you do not have to take the TOT. Dogs with a NW3, SDDA Excellent or UKC Level 5 title may skip the Novice level and start PSD at the Advanced level. **Can I watch other competitors?** Yes you can watch, either after you run or you can watch a different level compete.

**Can my friend videotape my searches?** Yes! And you may post them anywhere you like.

**Awards:** Rosette placement ribbons will be awarded for 1<sup>st</sup>-3<sup>rd</sup> place. Ribbons will be awarded for Q's in all classes, including TOT's. We offer an Iron Nose Award for Teams Qualifying in all classes possible each day (excluding TOT). Perfect weekend Rosettes are awarded for dogs that Q in all 10 regular classes. Metallic dogs will be scored together.

**Please make checks payable to Lucky Dog Events. Do not make checks payable to PSD.**

**Collars** No prong, choke or electric collars are allowed. Only a flat, or martingale collar or leashes attached to a dead ring or harness are permitted to be used during a search. No tags on collars while searching. All dogs must be leashed at all times, except during an off-leash search. **NO FLEXI LEASHES.**

**Crating** There will be no inside crating – you will need to work out of your car

**Parking** Huge parking area. Please watch for cone or signs indicating an area is off limits for parking-it may be a search area.

**Spectators** are invited to come and watch a PSD trial or a match. Spectators please leave your dogs at home.

**Volunteers** will help our Trial run smoothly. We need Timers, Gate Stewards, Score Runners, and Others. No Experience Required! No need to give up a day-volunteers get to run first in their class. Thanks in advance for your help.

**Food** - POT luck – please bring something to share and keep the judges fed and happy.

**Facility, Bathrooms and Water** Outhouse not running water – please bring water for you and your dog.

**Accessibility** there is an entrance with no stairs. However, judges might be using that area for a search. There are a few steps to get in a different entrance.

**Dogs In Need of Space** Please keep dogs 10 feet or more from other dogs. Please remember that PSD does allow reactive dogs to play, this does not mean aggressive dogs. **Dogs must be able to potentially wait in an area with other dogs and be in other situations where they are within 4 to 8 feet of other dogs and people** Volunteers will be onsite to help escort participants to and from the search area. Red bandanas are not required, but are suggested **PLEASE GIVE ALL DOGS SPACE.**

**Handler running multiple dogs:** A handler can run multiple dogs in TOTs at any trial/match. At this trial, a handler may only run one dog in each class. A second or third dog can run FEO.
