**\*\*We will only be accepting mail in entries for this trial.\*\* Entries received prior to the opening date will not be accepted. Entries will be accepted and entered in the order they are received.**

Entries are very limited and accepted on a first received basis.

### **Cancellations/Move-Ups/Changes/Refunds:**

- Cancellations received on or before October 10, 2020, full refund.

- If you earn a title in the entered class before this trial, please contact the trial secretary no later than October 19, 2020, in writing via email for move-ups.
- Next day move-ups will not be available for this trial due to the schedule of levels/classes being offered. Also, please remember that you cannot enter a level for which the dog is not yet qualified in anticipation of earning a title and moving up.

### **Come and have FUN with your dog!**

**Who can compete in a trial?** Any and all dogs that are 10 months or older, on the day of the trial or the Target Odor Test (TOT), are eligible to compete. All dogs must have their current rabies vaccination and other vaccinations recommended by your veterinarian.

**Do I Need to Register with PSD?** PSD registers dogs not people. A \$30 registration fee is good for the lifetime of the dog and can be done instantly on-line.

**What if I don't pass the TOT?** You can still play!! Dogs must pass a Target Odor Test (TOT) in order to compete in the Standard Division, however if you do not pass you are still allowed to enter the trial as FEO (For Exhibition Only) for the day.

**My dog has a Nose Work title from a different organization, do I have to pass a TOT?** If you already have passed an odor test in another scent work organization, you do not have to take the TOT. Dogs with a NW3, SDDA Excellent, UKC Level 5 or AKC Excellent overall title may skip the Novice level and start PSD at the Advanced level. Please send a copy of your test results to [info@performancescentdogs.com](mailto:info@performancescentdogs.com) in order to register.

**Can I watch other competitors?** Due to COVID, spectators will not be allowed at this trial.

**Can my friend videotape my searches?** Due to COVID, videotaping will not be allowed at this trial. However, permission has been granted for handlers to use a Go Pro or similar device during their searches.

**Awards:** Rosette placement ribbons will be awarded for 1<sup>st</sup> - 3<sup>rd</sup> place in the Standard division. Placement ribbons will also be awarded for 1<sup>st</sup> – 3<sup>rd</sup> place in the Metallic division. Ribbons will be awarded for Q's in all classes, including TOT's. Title ribbons will also be available in both the Standard and Metallic divisions.

**Iron Nose Award:** We will be offering an "Iron Nose Award". On Saturday, it will be awarded to those dogs who qualify in all (5) classes offered each day (no matter the level). On Sunday, it will be awarded to those dogs who enter/qualify in all Novice classes (4) and another for those dogs who enter/qualify in all Excellent classes (5) being offered.

**Perfect Weekend Award:** We will not be offering this award at this trial.

**Fees:** TOTs: \$15.00 / Classes: \$20.00 / "Day of" (if any open spots): TOTs: \$20.00 / Classes: \$25.00

**TOT's:** Due to the restrictions in place as to how many people can be in the building over the weekend, we are asking that you only enter TOT's if you are also entered in other classes for this trial.

**Facebook Group:** A Facebook group will be created specifically for this trial to post important information. The judge's debriefings will also be posted in the group. You will receive more details via email.

**Remind App/Group Text:** The Remind phone app or a group text option will be employed the days of the trial to keep everyone updated. More information will be sent out closer to the trial.

**General/Judge's Briefing:** There will be no in-person briefings due to COVID. The briefings will be sent with the final confirmation email and will also be posted in the Facebook group.

**Ribbons/Awards:** There will be no in-person ribbon ceremony due to COVID. The process for picking up ribbons/awards will be detailed in the final confirmation email.

Please mail a check/money order, along with your entry form(s) & signed/dated Release of Liability Waiver, to the trial secretary listed below. Checks/money orders will be deposited after the closing date. To redeem K-9 Scent Crew worker bucks you earned from a previous trial, make a note on the entry form and remit your check for the remaining balance (minus the amount of worker bucks). **Entries will be accepted and entered in the order in which they are received. A wait list will be maintained and you will be notified on any changes that impact your status on the list.**

**Collars:** Any collar is allowed on the grounds except scent spraying collars. Only a flat, or martingale collar or leashes attached to a dead ring or harness are permitted to be used during a search. No tags on collars while searching. All dogs must be leashed at all times, except during an off-leash search.

**Crating:** Indoor crating will not be available at this trial. The parking lot is not shaded so please make sure you bring fans, shade cloths, etc. to keep your dogs cool & comfortable. If the weather is cold, bring what you need to keep you and your dog warm in the vehicle. Dogs must be crated or kept comfortably in your vehicle while not running or pottyng.

**Parking:** There will be signs and/or someone to direct you to the parking area. Please watch for cones or signs indicating an area is off limits for parking-it may be a search area.

**Arrival Times:** Competitors that are participating in only Novice and/or Novice and Advanced on Saturday and in only Novice and/or Novice and Excellent on Sunday can arrive starting at 8:00 am. For competitors only entered in Advanced on Saturday or only entered in Excellent on Sunday, arrival times will be sent out in the final confirmation email. Due to COVID restrictions, we ask that once handlers have finished all of their searches for the day and received their results/ribbons/awards, that they leave the campus.

**Spectators** are not permitted at this trial due to COVID. We ask that only handlers who are entered and running a dog attend. Please do not bring any extra spectators to the campus.

**Donations:** Unfortunately, due to COVID, there will be no raffle baskets at this trial.

**Food:** There will be no food available at the trial site. Due to COVID, sharing of food in the parking lot is discouraged. There are a number of fast-food restaurants located within a two

mile radius of the trial site for lunch or you may want to bring your own if you are entered in both levels that day.

**Facility, Bathrooms and Water:** The facility is climate controlled with indoor bathrooms. There is no smoking allowed at this facility, including e-cigarettes and no alcohol allowed on the premises. Please make sure to pick up after your dogs.

**Trial Site:** Please do not visit or contact the trial site prior to the trial date. Also, no training should take place at the trial location.

**Accessibility:** No stairs or steps for entry into the building. Email the TS for more information.

**Dogs In Need of Space:** The site has plenty of parking and places to walk dogs at a distance of 10 feet or more. Red bandanas are encouraged - ***please give all dogs space.***

**Dogs in Season:** Females in season may participate wearing appropriate britches at all times except in the toileting areas. Females in season will run after the last dog in each search area. Handlers must notify the club as soon as possible so accommodations may be made for toileting areas and run order adjustments.

**Handler running multiple dogs:** A handler can run multiple dogs in TOTs at any trial/match. At this trial, a handler may only run one dog in each class. A second or third dog can run FEO or in a different class.

**\*\*FAILURE TO COMPLY WITH ANY OF THE BELOW LISTED COVID REQUIREMENTS COULD RESULT IN BEING ASKED TO LEAVE THE TRIAL WITHOUT A REFUND\*\***

- Each day, before you arrive on campus, you are required to fill out and submit the Screening Assessment tool from your cell phone/tablet at this link: <https://www.volstate.edu/pioneers-protecting-pioneers> If you will be trialing both days, you will need to fill it out Saturday and again on Sunday. This is a requirement of Volunteer State Community College. This form will ask for your first/last name, phone number, email address, date of campus visit and that you are a visitor on the Gallatin campus, whether you have been in close contact with a confirmed case of COVID-19, if you are experiencing a cough/shortness of breath/sore throat, if you have had a fever in the past 48 hours, if you have new loss of taste/smell, if you have experienced vomiting or diarrhea in the last 24 hours, if your temperature is greater than 100.4 and acknowledgment that you have read the safety guidelines.
- **Masks will be required to be worn at ALL times while on the Vol State campus.** Face shields and neck gaiters will not be permitted. Face shields will only be allowed if a mask is also worn underneath the shield. **Masks may only be removed while you are sitting in your personal vehicle.** This is a requirement of Vol State and must be followed. If anyone is found to be without a mask, they will be asked to leave the trial and will not receive a refund.
- Social Distancing requirements are mandatory. There is no option to mutually consent to be closer together than 6'. Please be respectful that your proximity or request for proximity may make others uncomfortable. If everyone does not adhere to social distancing, we could lose use of the facility.
